Basic Budget

✓ Make a one-on-one budgeting appointment if:

✓ You have no money left at the end of the budget or show a deficit at the end of the month

✓ You don't have enough money to meet your monthly expenses

✓ Your budget shows that you should have money left at the end of the month but, in reality, you don't

✓ You have questions/concerns/issues you consider too personal to discuss in front of the group

Basic Budget

✓ What to buy?

✓ You should have big ticket items by now – crib, stroller, car seat, etc.

✓ Wait to purchase anything more until after baby showers and other gifts received

✓ Make sure you register for needed items

Life Insurance

In case of death

✓ SGLI - Amount based on member's election (\$5,000 min to \$400,000 max), proceeds are non-taxable, normally paid within seven days, pays on all types of death

- ✓ Social Security
- ✓ Veterans' Benefits
